### Example:

You have 10 reels that are 3 inches (500 feet) and 2 reels that are 7 inches (800 feet). Based on the reel size you have about 1300 feet of film to be converted. Fill out this form as shown below.

In this example, for a DVD, film conversion would be \$156.00. This would include a DVD, Title page and chapter breaks. There would be no menu to select chapters.

In this example, for a Flash Drive, conversion would be \$130.00. This would include chapter breaks. Flash drive cost would be customer provided or we can provide at cost. There would be no menu to select chapters.

If you are dropping off your reels at our office, you can do so at our address below. We have a brown drop off box that you can place your reels inside of. This is located inside our home/office porch entrance on the right side. We will process the reels and keep you updated via email on the progress of your project.

If not, place reels along with your order form in a strong box, packed to hold your reels secure. Your local Post Office has boxes that can be purchased to hold your reels for shipment.
